Issue	Mark Warner (D)	Daniel Gade (R)	Warner's Votes
Limit unemployment benefits to level of pay in last job.	O	NR	Voted on 3-26-20 against Sasse amendment to H.R. 748 to ensure additional unemployment benefits do not result in compensation that is more than the amount of wages the individual was earning prior to becoming unemployed.
Remove President Trump from office for abuse of power and obstruction of justice.	S	NR	Voted 2-5-20 to remove President for Abuse of Power, then for Obstruction of Justice
When a baby survives an abortion attempt, require medical personnel to exercise care to preserve its life.	O	NR	Voted on 2-25-20 against ending debate to allow vote on S. 311, the Born-Alive Abortion Survivors Protection Act.
Overturn the Trump rule that lets states determine how to reduce greenhouse gas emissions from electrical generating facilities.	S	NR	Vote on 10-17-19 for S.J. Res 53, Congressional Disapproval of rule to repeal Clean Power Plan.
Prohibit abortion after 20 weeks when a baby is capable of feeling pain.	O	NR	Voted 2-25-20 against ending debate to allow vote on S. 3275, Pain-Capable Unborn Child Protection Act.
Do not put a ceiling on the amount of debt the federal government can take on.	S	NR	Voted on 8-1-19 to end debate and vote on H.R. 3877 to suspend ceiling on public debt through 7-31-21 and increases spending.

Permanently prohibit the use of federal funds for abortions except to protect a mother's life or in cases of rape or incest.	<b>O</b>	<b>NR</b>	Voted on 1-17-19 against ending debate to allow vote on S. 109, prohibiting federal funding of abortion or abortion insurance.
Prohibit the FBI from obtaining FISA Court wiretap authorization for American citizens for use as evidence in court.	<b>O</b>	<b>NR</b>	Voted 5-14-20 against Paul amendment to H.R. 6172 to prohibit Foreign Intelligence Surveillance Act (FISA) court authorization of surveillance of U.S. citizens use in civil and criminal cases.
Prohibit States from allowing the sale of health insurance plans that do not cover all Obamacare mandated services.	<b>S</b>	<b>NR</b>	Voted 10-30-19 for and sponsored S.J.Res. 52 to disapprove regulation authorizing State Relief and Empowerment Waivers.
Override any veto of a bill slowing the building of a border wall.	<b>S</b>	<b>NR</b>	Voted 10-17-19 to override veto of S.J. Res. 54, reversing national emergency declaration to prevent enhanced efforts to build border wall.
Limit floor debate on Presidential nominations to 2 hours and approve them by a simple majority vote.	<b>O</b>	<b>NR</b>	Voted 4-2-19 against S.Res. 50, changing Senate rules to allow breaking a filibuster on confirming presidential nominations with a majority vote after two hours debate, instead of 60% vote and 30 hours of debate.
